## ART. 21 - PENALTIES

1 Violation of the abovementioned regulations will lead to penalties in accordance with Article 33 of Regional Law no. 19, of 28/4/1998.

### KEEP IN MIND:

- If the association booklet and fishing permits are not returned by 31st December, a fine of 136,00 Euros will be applied.
- **All of the association booklets, standard, no kill, total catch, Carp fishing booklet and permits, must absolutely be returned by 31st December, to the zone headquarters during the days and hours specified or sent by post.**

- **Failure to fill out the total catch and number of outings will lead to a fine of 20,00 Euros to be paid when renewing with the association for the following year.**
- **Use of proper terminal tackle is advised for pike fishing.**

**The association cannot be held responsible for accidents or injuries that could occur during the fishing outing.**

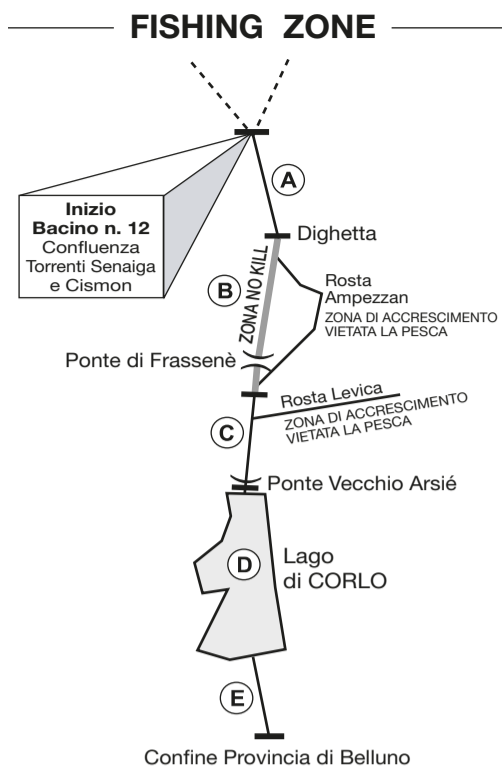
**FOR ANYTHING NOT STATED IN THE ABOVE RULES AND REGULATIONS, THE PROVINCIAL AND REGIONAL RULES AND REGULATIONS APPLY**

### NOTE:

**in order to protect pike it is preferable to not bring it on dry areas for unhooking and/or photos.**  
**A long pole, shears or clippers are also advised along with a small mat if needed, in order to facilitate the unhooking.**

### IMPORTANT

**According to Comma 5 of Art. 12 of Regional Law no. 19/1998, use of echo sounder, sonar, live scope and any type of electronical or mechanical devices, used for identifying fish species, are prohibited within salmonid and cyprinid waters.**



## FISHING REGULATIONS FOR ZONE 12

### FISHING DOCUMENTS

- In order to fish, the following documents are required:
  - Fishing license, Yearly document of Zone Association (Associazione al Bacino), or Temporary Permit.
  - Valid identification document
- The fishing document, or Temporary Permit, must be completed in all its parts with black or blue ink, before beginning to fish.
  - **Specimens taken must be marked immediately after they are collected.**
  - **Zone Members must mark specimens in the appropriate booklet, and member booklet immediately after they are collected when fishing is completed.**

### FISHING EQUIPMENT AND METHODS

- In salmonid waters (Cison Creek):**
  - Fishing is allowed with one single fishing rod, and one single hook with a single point at the terminal, barbless or with flattened barb.**
- In cyprinid waters (Lake Corlo):**
  - Fishing can be practiced with a maximum of three fishing rods, with not more than three hooks each, with one or more points at the terminal.
  - For bass fishing, when one fishing rod is being used, this can have a maximum of five hooks as long as artificial bait is used. This artificial bait is commonly called, "ciucci".
  - Use of a paternoster rig is allowed with a maximum of three baits.
- Fishing from bridges or motor vehicles is prohibited.
- Passing the overhead signs in proximity of the dam by boat is prohibited.**
- Use of boops, or gaff, is prohibited.**
- Fishing net is required.**
- Electric motor tow is prohibited.**

### USE OF BAIT

- Fishing with live or dead small fish as bait is prohibited in all the waters of the zone.**
- Use of carnaria fly larvae is prohibited in all the waters of the zone.**
- From the beginning of the fishing season until, and including, May**

## FISHING LICENSE ZONE 12 LAKE CORLO AND LAKE CISMON RULES AND REGULATIONS 2025 SEASON

### AREAS WHERE YOU CAN FISH

- Cison Creek from the confluence of Senaiga Creek to the crossing of Pedesalto (dam).
- Cison Creek from 1,3 meters downstream of the Frassenè bridge to the old bridge of Arsiè.
- Lake Corlo, from the old bridge of Arsiè to the pre-dam limit.
- Cison Creek from the Corlo dam to the end of the concession.

### AREAS WITH PARTICULAR FISHING REGULATIONS (NO KILL)

- Cison Creek from the crossing of Pedesalto (dam) to 1,3 meters downstream of the Frassenè bridge.

### AREAS OF GROWTH (FISHING NOT ALLOWED)

- Rio Auric.
- Rosta Agana (organic rest).
- Rosta Levica.
- Carazzagno Creek.
- Rosta Ampezzan.

**Beginning of fishing season: 2 March.**

**End of fishing season in salmonid waters (Cison Creek): from Monday 29 September.**  
**End of fishing season in cyprinid waters (Lake Corlo): 30 November for non members, 31 December for members.**

**31st, in Lake Corlo, fishing with artificial bait is allowed only from boats and only with artificial bait with maximum size of nine centimeters. Use of dry fly, not cast from the bank of the river, with only a single hook and a single point, without barb or flattened barb, is allowed. Use and possession of any other type of artificial bait is prohibited in this period.**

- Use and possession of artificial bait with barbed hooks is prohibited in Lake Corlo. (Unless they are barbless hooks.)**
- When using artificial hooks of over 14 centimeters, with hooks with more than one dart, use of a metal or fluocarbon lines with a diameter of minimum 0.55 mm e lenght not under 20 cm, are required.**
- The possession of all types of bait prohibited by regulation L.R. 19/98 Art.12 c. 7 bis are prohibited.**

### NO KILL ZONE

- In order to fish in the No Kill Zone of Cison Creek, it is necessary to be a member authorized by concessionaire, or be in possession of a specific permit.
- All types of live or silicon baits are prohibited.**
- Only one hook, with a single terminal hook, barbless or with flattened barb.
- Three prong fishing hooks are prohibited.**
- Captured fish must be immediately released.
- For members and non members in Zone B No Kill at Cison Creek only dry fly fishing with a single barbless hook (or with flattened barb) is allowed. This being from the last Monday of September until the end of October.  
Note: **it is strongly recommended to handle the fish with caution and not place it on rocks, sand etc. during the unhooking and/ or photographing.**

### PROHIBITED FISHING PERIODS

- In salmonidae water fishing is prohibited on Tuesdays except in the no-kill zone (zone B), and from one hour after sunset to one hour before sunrise.**
- In Lake Corlo night fishing is allowed only to fishermen who

practice carp fishing from designated areas and in possession of a specific permit.

3 For the following species, fishing is also prohibited in the periods listed below:

- Grayling: from the last Monday of September to 15th May.
- Pike: from 1st January to 31st May
- Perch: from 1st December to 31st May
- Carp and tench: from 15th May to 30th June.

4 **In Zone 12 it is prohibited to keep the following species:**

- Bleak
- Carp
- Pike
- Grayling
- Marble trout and its hybrid
- Brown trout

### MINIMUM LENGHT

The minimum lenghts for fish caught, for species allowed and where capture is allowed, are as follows:

- pech: cm 15
- tench: cm 50
- chub: cm 25

**Pike-perch must always be kept.**

### FISHING ALLOWED

1 For the 2025 season:

**KEEPING SALMONIDS IS PROHIBITED IN THE WHOLE TERRITORY OF THE ZONE**

2 Within Zone 12 the fisherman can catch daily, a maximum of :

- 15 perch - with a maximum of 250 annually -
- In Zone 12 waters each fisherman can catch a total amount of, for each day of fishing, a maximum of 5 Kg of fish, unless the limit is exceeded because of the last fish caught.  
The pike-perch (Sandra), being invasive is not included in the 5 Kg total.

**On Tuesday, fishing is prohibited only in salmonid waters except for Zone B (No Kill) of the Cison stream.**
